Quotations are hereby invited for the work of "Procurement of services for the launch as Floating Restaurant & Cruise Tours on lease agreement basis at Chandannagar" from reputed hotel / restaurant company or restaurant owners.

- 1) In the event of e-filling, intending bidder may download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate. Necessary Earnest Money has to be deposited by the bidder through the following payment mode as per Memorandum of Finance Department vide No. 3975- F (Y) dated 28th July, 2016.
 - i. Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway.
 - ii. RTGS/ NEFT in case of offline payment through bank account in any bank.
- 2) Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <http://wbtenders.gov.in>
- 3) Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated in clause No. 15

- 4) The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the bidder is found qualified by the 'Tender Evaluation Committee' formed by the Managing Director, WBTDCL Ltd. The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.
- 5) **ELIGIBILITY CRITERIA:**
- i) The Perspective bidders shall have satisfactorily handled any restaurant type facilities or like that within 2 (Two) years.
 - ii) The bidders should have the establishment of hospitality / hotel management within 2km of the jetty.
 - iii) The bidders should have own cooks and service personals to take up day to day restaurant services and catering facilities for taking up cruise trips for 2 to 3 days.
 - iv) The bidder should have well conversant qualified hotel & hospitality manager on permanent basis.
 - v) The Perspective bidders should have requisite license (i.e. Trade License) for public food services, hygiene & health clearance certificate, GST, Pan Card, Balance Sheet and statement of Accounts audited by chartered accountant for last 3 Years.
 - vi) The rates to be quoted on yearly / monthly basis.
 - vii) The entire necessary infrastructure like jetty, Pontoon gangway and service launch including the pilot will be supplied by WBTDCL.
 - viii) All service pantry equipments and utensils & cookeries are to be arranged by the bidder.
 - ix) All safety & security measures are to be arranged by the bidder.
 - x) Necessary fire safety measures will have to be take care along with the 'Fire License'.
