## Terms and conditions of the Auction

- 1) The organizations of the Registered Functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities, Individual / Entrepreneur connected to fishery activities should possess ample initiative, Capacity for Organizational Expansion, Financial solvency and good will.
- 2) Registration Certificate, etc. Of the organization, applicable. as a proof of claim of the organization.
- 3) The eligible Registered Functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities, Individual/Entrepreneur connected to fishery activities must obey the Govt. Rules to participate the auction.
- 4) The bid submitted by participating bidders of Registered Functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities, Individual/ Entrepreneur connected to fishery activities will be valid for period of 3 (three) years (from date of notification of this notice).
- 5) The representatives of the participating bidders of Registered Functional Primary Fishermen's Co- Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities, Individual / Entrepreneur connected to fishery activities should deposit Bank Draft amounting @10% of the minimum economic lease rent as bid security, as shown against above mentioned Govt. Fishery, in favour of Superintending Engineer, WBTDCL.
- 6) At present, WBTDCL conducts water sports like, speed boat, paddle boat and allied activities on Motijheel "BIL" without hampering the activities of Pisciculture. WBTDCL shall reserve the right to conduct such activities during the currency period of Lease agreement.
- 7) The minimum economic lease rent for settlement of the Govt. Fishery are shown in the list attached herewith. (Annexure "A")
- 8) 25% of the accepted highest valid bid offer is to be deposited within 15 days from the time of settlement and the remaining full amount of lease rent must be deposited within the following three (3) months, failing which the earnest money of the highest valid bid offer submitted by the successful highest bidder in the form of bank draft as earnest money will be forfeited. In case of nonpayment of full amount of lease rent for the first year, with in three (3) months of the date of settlement by the lessee concerned, the said lease will be stand cancelled. In successive years also, the lease rent of that year must be deposited in full prior commencement of that year (Bengali year). Otherwise, the said lease will be cancelled and earnest money thereof will be forfeited with one month's notice.
  - a. Moreover, in that case if the second highest valid bidder is willing, will take settlement of the same for the remaining years at the bid value submitted by the highest bidder (1<sup>st</sup>year or 2<sup>nd</sup> year or 3<sup>rd</sup> year as the case may be) and continue fishery activities therein in the same conditions and so on. - 9) The appropriate authority reserves full right to postpone, cancel or accept the settlement work of the Govt. Fisheries without assigning any reason.
- 10) After the settlement has been accepted by the Government, the highest bid offering Registered Functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities, Individual / Entrepreneur connected to fishery activities will have to come to a written agreement with WBTDCL.
- 11) Prior to the participation in the auction the Registered Functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities, Individual / Entrepreneur connected to fishery activities will have to submit documentary evidences in support of their claim that the entire arrear dues regarding other Govt. Fisheries was paid by them, otherwise they may not be considered eligible for participation in the auction.

- 12) All the authorities of the Registered Functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities, Individual/Entrepreneur connected to fishery activities must comply with all the Rules, norms and conventional procedures and restrictions, relevant to the settlement of the Govt. Fisheries and sublease of any Govt. Fishery is strictly prohibited.
- 13) Participation and bidding by anyone in this auction be treated as conclusive evidence of the fact that the party has inspected the site of Motijheel Fishery Tank and satisfied himself in all respect regarding extent of tank fishery, ingress and outguess to and from the fishery with local physical and working condition of Motijheel Fishery Tank.
- 14) It shall be implied and taken for granted that the party has carefully gone through and understood the terms and conditions of e-Auction including the amendments, if any, prevailing at the time of bid. No complaints or objections shall be entertained by any authority after the bid is opened/accepted.
- 15) There should be at least three eligible bidders to start the e-Auction process. If the number of such bidders is less than three then the e-Auction process would be cancelled and the Earnest Money/ security money will be refunded.
- 16) There shall be reserve price which is kept confidential vide order no 4068 F (Y) Dated- 25.05.2015 and if the highest bid in e- Auction is less than the reserve price the e-Auction shall be summarily cancelled and the security money/ earnest money deposited will be refunded after the bid value is examined by the competent authority in WBTDCL and found to be lower than the Reserve Price. - 17) The sale of fish would be made in favour of one successful bidder who has quoted the highest rate equal to or greater than the reserve price and who have been found to have fulfilled all the conditions of e-Auction Notice stated in this document.
- 18) The word successful bidder/Buyer means a bidder whose rate has been accepted by the Auction accepting Authority.
- 19) If the successful bidder fails to honour the bid, then the security deposit / earnest money deposit shall be forfeited and he shall be barred from participation in all other auctions of Department of Tourism/WBTDCL. Also, if any of the bidders having participated in the technical proposal fails to participate in the e-Auction the earnest money deposit may be forfeited.
- 20) The intending bidders are requested to visit the places where the Motijheel Fishery Tank having 196.97 acres is lying after intimating and obtaining information from the concerned Manager, Motijheel Eco Tourism Property regarding location of Motijheel Fishery Tank and road linkage of Lalbagh Town with the tank the listed in Annexure-A. Bid may be submitted online after such inspection of the site of Motijheel Fishery Tank. Expenditure incurred by a bidder for preparing bid documents and for inspection shall have to be borne by the bidder and no claim in this regard shall been entertained.
  - a. Auction inviting authority/WBTDCL reserves the right to cancel the e-Auction at any stage and the authority inviting this auction shall not be liable to pay any compensation to any bidder for any loss that they may incur due to such cancellation.
- 21) Only courts in Kolkata shall have the jurisdiction for resolving any dispute arising out of this e-Auction.
- 22) In connection with any dispute arising out of this e-Auction, Arbitration will not be allowed. The dispute will first have to be laid before the forum specified in the dispute resolution mechanism prescribed by the Govt. of West Bengal. Bidders may peruse Finance Department Memo No.8182-F(Y) dated 26/09/2012.
- 23) Participation in the bid of Jalkar of this e-Auction shall be treated as acceptance of all the terms &conditions as mentioned in this notice and also acceptance of all modalities as mentioned in this notice.
- 24) WBTDCL shall not be responsible for any malfunctioning or non-functioning of any bidder's computer either on account of DSC (Digital Signature Certificate) or for any other reason Bids submitted by a bidder after signing with his/her DSC signifies non-repudiation by the bidder. ## **Auction Process:**

Incomplete information may lead to rejection.

- **40)** The successful bidder at his own cost has to adopt all safety/preventive/precautionary measures following relevant rules of the Government for safe disposal of all pisciculture products. Permission from appropriate authority if needed for such process has to be procured from the end of the bidder at his own cost failing which the earnest money of the bidder will be forfeited.
- 41) Any damage or loss of Government/public/private property or life during the process of lifting p is ciculture product will be the sole responsibility of the successful bidder and the successful bidder has to defray the cost of such damage at his own cost as per estimate prepared by this office, failing which the earnest money of the bidder will be forfeited without any prejudice to the rights of WBTDCL/Tourism Department, Go WB to take any other action as appropriate.
- **42)** The dates and times published online are final and no request for any change will be entertained under any circumstances. Moreover, no objection in any form shall be entertained after completion of on-line scrutiny of documents.
