Quotations are hereby invited for the work of “Procurement of services for the launch as floating restaurant & cruise tours on lease agreement basis from BabuGhat Jetty” from reputed hotel / restaurant company or restaurant owners.

- 1) In the event of e-filling, intending bidder may download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate. Necessary Earnest Money has to be deposited by the bidder through the following payment mode as per Memorandum of Finance Department vide No. 3975- F (Y) dated 28th July, 2016.
 - i. Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway.
 - ii. RTGS/ NEFT in case of offline payment through bank account in any bank.
- 2) Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <http://wbtenders.gov.in>
- 3) Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated in clause No. 15
- 4) The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL BID** of the tenderer is found qualified by the ‘Tender Evaluation Committee’ formed by the Managing Director, WBTDC Ltd. The decision of the ‘Tender Evaluation Committee’ will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.

5) ELIGIBILITY CRITERIA:-

- i) Experience in vessel operation for at least 2 years.
- ii) The Perspective bidders shall have satisfactorily handled any restaurant type facilities or like that within 2 (Two) years.
- iii) The bidders should have the establishment of hospitality / hotel management within 2km – 5km of Jetty.
- iv) The bidders should have own cooks and service personals to take up day to day Restaurant services and catering facilities for taking up cruise trips for 2 to 3 days.
- v) The bidder should have well conversant qualified hotel & hospitality manager on permanent basis.
- vi) The Perspective bidders should have requisite license (i.e. Trade License) for public Food license, hygiene & health clearance certificate, GST, Pan Card, Balance Sheet and statement of Accounts audited by chartered accountant for last 3 Years.
- vii) The rates to be quoted on yearly / monthly basis.
- viii) The entire necessary infrastructure like jetty, Pontoon gangway and service launch including pilot will be supplied by WBTDC.
- ix) All services, kitchen, pantry equipment and utensils & cookeries are to be arranged by the bidder.
- x) Owner of Hotel / Restaurant either permanent / lease basis.
- xi) If any experience of work in similar nature of work.
- xii) All safety & security measures are to be arranged by the bidder.
- xiii) EMD @2% of the quoted amount should be submitted at the time of agreement of the accepted bidder.
