The bills should be submitted along with duplicate challans having signature of concerned Institute authorities. Upon receiving the bill WBTDC will process the bill for payment subject to satisfactory certificate from the competent authority.
- 12. That the supplier/contractor shall furnish a warranty in the format enclosed on Stamp Paper or on plain paper of Rs.100/-.
- 13. That any over payment of the Supplier's bills for the supplies made under these terms and conditions shall be recovered from the supplier's bills subsequently submitted for payment and if such over payments or any portion thereof or thereafter remitted by the supplier the amount so recovered will be refunded to the supplier. WBTDC shall have the right to recover the overcharges, from the security deposit as well.
- 14. That WBTDC shall pay for such approved material as shall be supplied by the supplier and accepted by the said committee/officers for and on behalf of WBTDC under or by virtue of these terms and conditions at the rates and prices which will be specified and contained in the Schedule after the tender has been approved.
