General Conditions

1. All interested candidates should apply from our online web

portal <https://www.wbtdcl.com> or <https://www.wbtourism.gov.in>, online registration form will be highlighted there. Candidates need to upload scanned recent Passport size photograph Signature, ID Proof, Age proof and Certificate/Mark sheet of educational qualification.

2. Candidates will have to produce the proof of details furnished in their applications, in original, in written test/interview.
3. An eligible candidate can submit not more than one application and for one post only. Moreover he/She can appear at one examination centre at Siliguri or Kolkata.
4. Application received after the due date, not filled correctly and applications incomplete in any respect will not be considered.
5. Only an Indian National can apply.
6. Canvassing in any form will be cause of disqualification. Furnishing of false information in any form would disqualify the candidature at any stage and attract penal action.
7. It may be noted that if, at any stage, it is discovered that an attempt has been made by the applicant to willfully conceal or misrepresent the facts, his candidature will be summarily rejected or his employment will be terminated.
8. Persons working in Government/ Public Sectors undertaking/ Autonomous Organization should submit their application through proper channel.
9. No TA/DA is admissible for applying selection test and interview.
10. Last Date for Submission of online Application will be 10th September 2018 which may be changed by further notice from higher authority.
11. No modification is allowed after submission of the application form. If any discrepancies are found between the information provided in the application in the application form and information from the photocopies/ original copies of the certificate / data furnished at the time of interview, his/ her candidature will be rejected.
12. Preference will be given for possessing more additional qualifications given in the notice.
13. If the submitted form and/or uploaded scanned copy is/are found to be false, the candidature will be suspended for lifetime in this corporation (WBTDCL)
14. For the recruitment of 13 Nos of Junior Asst., 130 candidates shall be called for

written test (1:10 ratio i.r.o. number of vacancy) on the basis of merit list prepared from applications received and 39 candidates shall be called for interview (1:3 ratio i.r.o. number of vacancy). The examination process would consist of MCQ written test (100 Marks), followed by Interview (50 Marks).

15. Based on scrutiny of the application received, a merit list shall be prepared internally for choosing 130 candidates who would seat for the written examination, if total number of eligible applications cross 130, following the principle given below:

So, a candidate with 100% score in Secondary, Higher Secondary and Hotel Management Degree, with 3 years experience, would score 70 (10+10+20+30) in the merit list prepared for inviting candidates to take written examination.
