
AUCTION NOTICE

Interested parties having adequate experience in the respective field and financial solvency are requested to visit the site and inspect the materials on any working days between **10.00 Hrs. to 11.00 Hrs. up to 17.06.2019** in the premises of Tarakeswar Tourist Lodge before participating in the auction.

The **RESERVE PRICE** of the said materials has been fixed at an amount of **Rs.34,434.00/-** (Rupees Thirty Four Thousand Four Hundred & Thirty Four Only) plus 18% GST (as applicable extra). The intending bidders/agencies have to submit the photocopies of the followings i.e. PAN Card, GST Registration Certificate, P.
